Official Notification of Cancellation of Liability Insurance

R.S 32:861, ET SEQ. Requires motor vehicles registered in this state to be covered by liability insurance or some other type of security. This applies even if the vehicle is located out of state or if the registration is expired.

This department has been notified by your insurance company that liability insurance or security on the vehicle described below has been cancelled.

Your registration will be revoked and cannot be renewed, and your driver's license blocked against renewal or reissuance ten (10) days from the date of this notice unless you submit the information below and, if required, pay the fee.

- 1) If the vehicle has **current liability insurance or you obtained liability insurance**, you must:
 - A. Provide an insurance card, declaration page or policy with an effective date within 1 day from the cancellation date, **or**
 - B. You must contact your insurance company or agent. Your insurance company or agent must electronically submit your insurance information to the Louisiana Insurance Verification System (LAIVS) using the www.LAIVS.org website and the reference number below.
- 2) If the vehicle is **inoperable, sold, totaled, repossessed, or registered out of state**, you must
 - A. Cancel the license plate. If the plate is cancelled within ten (10) days of the date of this notice, you will **not** owe a fee. **Or**
 - B. Submit a copy of the bill of sale, trade in document, lease return document, total loss statement from the insurance company, proof of repossession, junk or salvage receipt, or an out of state registration. If this was done within ten (10) days of the cancellation date, you will **not** owe a fee.

The status of the vehicle must be provided for clearance of this violation and calculation of possible fees owed. Failure to resolve this matter may result in referral to the Office of Debt Recovery (ODR) for collection assistance.
